

Terms and Conditions:

a. Definitions

For the purposes of these terms and conditions ("Terms and Conditions"):

- "Card" shall mean debit card, which has been issued by ICICI Bank and is valid and subsisting during the Program Period.
 - "Card Holder/s" shall mean such customer/s to whom a Card has been issued and who is authorized to hold the Card and who has received the communication from ICICI Bank with respect to the Program by way of e-mailer /sms or through any other mode as per the discretion of ICICI Bank .
 - "Cash Back" shall mean the amount credited back to the Card Account as per terms specified in the Program.
 - "Program" shall mean the "ICICI Bank Debit Card Cash Back Offer".
 - "Primary Terms and Conditions" shall mean the terms and conditions applicable to the Card in addition to these Terms and Conditions.
 - "Program Period" shall mean period commencing from **December 20' 2008** to **March 20' 2009** (both days inclusive).
 - "Void Transaction" shall mean any transaction wherein the transaction has taken place but has been cancelled by the Merchant Establishment prior to settlement with ICICI Bank.
 - "Retail Purchase / Transaction" shall mean such purchase of goods /services, which has been made by the Card Holder/s by swiping the Card on any bank's electronic data capture terminal.
- All capitalized terms used but not defined herein shall have the respective meanings ascribed to it in the Primary Terms and Conditions.

b. Program / Offer

- The Program is valid for the Card Holder/s only and shall be valid and subsisting during the Program Period, unless otherwise notified by ICICI Bank.

To avail Cash Back under the Program, the Card Holder/s shall be required to do Retail Purchase/s for a specific amount or specific number of Retail Transaction/s as mentioned in the slab below, during the Program Period using their Card on any Bank's electronic data capture terminal. Each Card Holder shall be eligible only for one Program and respective Cash Back amount as specified in the communication and the Program shall be valid only on Retail Purchase/s made/ done by using that Card whose number, ICICI Bank shall specify and communicate to the Cardholder by way of direct mailers/ emailers or sms or any other mode as per discretion of ICICI Bank.

- The amount of Cash Back shall be credited to Card Holder's account within 90 days succeeding the Program Period.
- The Program is applicable only to Primary Card Holder who has been communicated about the Program by way of emailer / sms or through any other mode as per the discretion of ICICI Bank.
- Cash withdrawals on ATMs and Online Transactions shall not be eligible for Cash Back.
- The Program is not valid for Void Transactions.
- In case of a cancelled transaction, the applicable Cash Back amount on that transaction would be debited from the account of the Card Holder.
- Acceptance of Cash Back by the Card Holder/s constitutes permission for ICICI Bank and its Affiliates to use the Card Holder/s name, photograph, other details which are furnished to ICICI Bank, voice and comments for advertising and promotional purposes in any medium without being liable to pay any additional charges to the Card Holder/s.
- The Card Holder/s shall not be eligible for reward points for transactions that are eligible for the Cash Back. The Program shall supersede the Reward Points program.

c. Other Terms and Conditions

- This Program is brought by ICICI Bank to select Card Holder/s as per the discretion of ICICI Bank.
- The participation in the Program is entirely voluntary and it is understood, that the participation by the Card Holder/s shall be deemed to have been made on a voluntary basis.
- If the Card Holder/s ceases to be Card Holder/s at any time during the currency of the Program, all the benefits under the Program shall lapse and shall not be available to the Card Holder/s.
- All disputes are subject to the exclusive jurisdiction of the competent courts/tribunals of Mumbai and shall be entertained by ICICI Bank till **August 20' 2009**.

- ICICI Bank shall not be liable in any manner whatsoever for any loss/ damage/ claim that may arise out of use or otherwise of any goods/ services availed of by the Card Holder/s under the Program.
- ICICI Bank reserves the right to modify/ change all or any of the terms applicable to the Program without assigning any reasons or without any prior intimation whatsoever. ICICI Bank also reserves the right to discontinue the Program without assigning any reasons or without any prior intimation whatsoever.
- ICICI Bank reserves the right to disqualify any Merchant Establishment or Card Holder/s from the benefits of the Program if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under the Program or otherwise by use of the Card at an ICICI Bank terminal.
- All taxes, duties, levies or other statutory dues and charges payable in connection with the benefits accruing under the Program shall be borne solely by the Card Holder/s and ICICI Bank

will not be liable in any manner whatsoever for any such taxes, duties, levies or other statutory dues. ICICI Bank shall be entitled to deduct or set off the amounts of taxes, etc., if any, mentioned above from all amounts payable by ICICI Bank to the Card Holder/s and balance amount, if any, of Cash Back will be paid to the Card Holder/s / credited to the account of the Card Holder/s.
