

## Terms and Conditions for "ICICI Bank Travel Card –Discount Program"

These Terms and Conditions (the "Terms") apply to and regulate the discount program provided by ICICI Bank on purchase of ICICI Bank Travel Card during the program period . These Terms are in addition to and not in derogation to the Terms and Conditions of "ICICI Bank Travel Card" (hereinafter referred to the "Primary Terms and Conditions") and which are available on [www.icicibank.com](http://www.icicibank.com). To the extent of any inconsistency between these Terms and Primary Terms and Conditions, these Terms shall prevail. All capitalized terms used herein but not defined shall have the same meaning as specified under Primary Terms and Conditions.

### **a. Definitions**

- "Card" shall mean ICICI Bank Travel Card, which has been issued by ICICI Bank Limited ("ICICI Bank") and is valid and subsisting during the Program Period.
- "Card Holder/s" shall mean a customer who applies for the Card and to whom a Card has been issued by ICICI Bank and who is authorised to hold the Card and who has received the communication from ICICI Bank with respect to the Program by way of direct mailer / e-mailer /sms or through any other mode as per the discretion of ICICI Bank.
- "**Program**" shall mean the discount made available by ICICI Bank to the Card Holder/s on foreign exchange buying rate on applying for ICICI Bank Travel Card during the Program Period at any ICICI Bank Branch offering foreign exchange services .
- "**Program Period**" shall mean the period commencing from 20<sup>th</sup> May,09 to 31<sup>st</sup> March,10 (both days inclusive).

### **b. Program**

- The Program is valid for the Cardholder/s only and shall be valid and subsisting during the Program Period, unless otherwise notified by ICICI Bank.
- ICICI Bank reserves the right to offer the Program to any Card Holder/s of its own choice and shall not be held liable to any Card Holder/s for not offering the same.
- In order to avail the discounts on foreign exchange buying rate as specified herein below, the Cardholder shall be required to visit an ICICI Bank Branch (where Foreign Exchange Services are being provided), and purchase the Card with denomination of USD, EURO AUD, CAD and GBP, during the Program Period. The Card Holder shall also be required to submit present an international air ticket purchased for a forthcoming visit and issued in the Cardholder's name by Jet Airways and the ICICI Bank's discount communication letter specifying the details of the Program.

#### **Discount on foreign exchange buying rate on purchase of ICICI Bank Travel Card**

- US Dollar – Rs 0.60
- British Pound – Rs 0.60
- Euro – Rs 0.60
- Australian Dollar – Rs 0.25
- Canadian Dollar – Rs 0.25

- Additionally, the Cardholder may also avail a one-time waiver of Card Joining fee worth Rs. 150 on the Card during the Program Period, only on fulfilling the

basic requirements specified above. For all other transactions, not eligible under the Program Period, the regular foreign exchange buying rate shall be applicable.

□The benefits under Program shall not be made available to the Cardholder/s in the event the Cardholder fails to fulfill and abide by the Terms stated herein and/ or the Primary Terms and Conditions during the subsistence of the Program.

□The Program has been made available to the Cardholder at the sole discretion of ICICI Bank and subject to change / amendment / modification from time to time. ICICI Bank, at its sole discretion, may at any time discontinue the Program without assigning any reasons or without any prior intimation whatsoever. ICICI Bank, may also review the benefits available under the Program with respect to each Cardholder at the time of making annual rental payments and shall be at liberty to vary the benefits / discounts offered under the Program.

**c. Other Terms and Conditions**

- The participation in this Program is entirely voluntary and it is understood, that the participation by the Card Holder/s shall be deemed to have been made on a voluntary basis.
- All disputes are subject to the exclusive jurisdiction of the competent courts/tribunals of Mumbai.
- If the Card Holder/s ceases to be a Card Holder at any time during the currency of the program, all the benefits under the program shall lapse and shall not be available to the Card Holder/s.
